Wedding Package #3: \$3800.00

- An additional photojournalist
- Up to 8 hours of photographic coverage*
- Proof Album with 4x6 color prints (approx. 400 photos)
- High quality digital images burned to a CD
- 1 digitally retouched 11x14 enlargement of Bride's choice
- 3 digitally retouched 8x10 enlargement of Bride's choice

Terms & Conditions

Your kind cooperation is requested in adhering to the following.

1. A minimum deposit of 50% is required as a retainer at the time the wedding date is booked by the client.
2. The remaining balance is due 2 weeks prior to wedding date.
3. All deposits are nonrefundable, in the event of a date change or wedding cancellation by the client for any reason.
4. Proof album and CD with digital images will be delivered in approximately four weeks from the wedding date.
5. If Nancy L. Ford is unable to perform to the guide lines of this contract due to a fire or other casualty, act of God, act of terrorism, or other cause beyond the control of the parties, or due to a grave illness of photographer Nancy L. Ford; and if Nancy L. Ford Photography is unable to provide a photographer that is agreeable to the client, then all fees paid by the client will be returned in full, but Nancy L. Ford Photography shall have no further liability with respect to the agreement. If Nancy L. Ford Photography is unable to perform to the obligations in this contract for reasons outside the sole control of Nancy L. Ford, she will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that negatives or digital images are lost through camera malfunction, damaged in processing, lost in the mail, or otherwise damaged or lost without fault of the photographer, Nancy L. Ford.
6. The client will obtain proofs and/or digital images which may be used for newspaper announcements. Images may be used for personal use only, and may not be sold or published without the written consent of Nancy L. Ford.
7. All rights to images created by Nancy L. Ford will remain with the photographer. Nancy L. Ford Photography reserves the right to display any photographs made in conjunction with this wedding as samples of her work for the purposes of window and showroom exhibit, advertising, promotion on the Internet, publication, instruction and professional competition.
8. Coverage plan times must be used consecutively. Time starts when Nancy L. Ford arrives and the time finishes when the coverage time runs out.
9. Photographing any specific moment is not guarantee by Nancy L. Ford Photography and she will not be responsible for any missed moments. The client may present Nancy L. Ford Photography with a list of suggested photos, but Nancy L. Ford is unable to guarantee that those suggested photos, or any image will be captured.
